

#### **Back to the Future?**

A Message from Jim Freyvogel, President/CEO MacDonald Training Center

In 1921, the State of Florida opened the *Florida Farm Colony for the Feeble Minded and Epileptic*. The stated purpose of this institution was to protect people with developmental disabilities by segregating them from society. The idea must have been popular because five other such institutions followed. All six eventually became know as Sunland Centers. By the late 1950's, nearly 10,000 Floridians were confined in these institutions. Their only crime was to have been born with a disability.

Forty years ago, the citizens of Florida realized their mistake and began to close these Centers and return the people to their communities. Now it appears that the Florida Legislature is about to reverse its position on community integration. There is a movement afoot to amend Chapter 393 F.S. which currently limits the number of individuals in a single community residential setting to six. The amendment would allow "gated, planned communities" consisting only of people with developmental disabilities. Once again the stated purpose of these communities is to protect people with developmental disabilities. This movement is buttressed by the state's desire to "do more with less" as it attempts to balance an ever shrinking budget. The formula is as simple now as it was in 1921... protecting people with developmental disabilities + cost efficiencies resulting from the warehousing of people = people being confined and segregated.

To all of you who have supported us and our mission over all of these years, we wish to assure you that MacDonald Training Center is **not** part of this new movement and that we are prepared to meet any challenge and pay any price to remain true to that mission. No matter the circumstances, we will continue to "empower people with disabilities to lead the lives they choose."
