### A Word From Ross

From the Desk of Ross O'Banion, Executive Director

July 1st marked the start of the new fiscal year for the state of Florida. This is an economy and a job market that is less than hoped for and, in fact, dismal at best. For Angels Unaware, Inc. and other providers of services for the Developmentally Disabled, July 1st marked yet another reduction in funding. This time, at the 4% level. There has been so many of these reductions in the past few years that most providers have lost count of the total percentage.

July also marked the announcement schedule for the new I-Budget. Oct 1, 2011 will start the rollout in the Northwestern part of the state. On Dec. 1, 2011 it will be parts of Central Florida, and then on Feb.1, 2012, the southern part of the state will see this new budget put in place. On April 1, 2012, all those remaining counties in the Northeast and those scattered across the state that were left out, will then join in. Simultaneously with the I-Budget, APD is rolling out its customer central record online system throughout the state. I wonder if April 1, 2012 will be anything like April 1, 2011 – the day APD announced a 10% reduction in funding. Later the legislature promised to find the money to cancel this action, which is why we have the 4% cut.

The question on everyone's mind at this point is really very simple. The I-Budget is supposed to give consumers and families the ability to control where their funding is spent. At the present time they still are required to have Support Coordination. A great question is "why?", as families and consumers will be making the decisions and tracking the budget. Once the money is gone in a consumer's budget they will get no more until the next budget year, unless it can be proved that the consumer's needs and challenges have increase to justify the increase (good luck). The I-Budget promises to be consistent so that everyone with similar challenges gets the same money across the state to spend. The question on everyone's mind is will it meet the needs? Will it be at a funding level to keep providers of services from going bankrupt? Having power to decide is long overdue, but having power to decide over consistent inadequate funding is another tasteless April Fools joke. Is the I-Budget one of these? No one knows yet. Yes, APD will stay in budget but how about the quality and level of care the consumers need?

The challenge for families is to continue to voice concerns to the Legislators, watch, talk, and work with others to see how the I-Budget is, or is not working as it is implemented across the state. Continue to work with service providers as they continue to provide services needed. Continue to push for adequate funding streams for those currently receiving funding and those approx. 19,000 on the waiting list. I-Budget places the consumer and families in the "driver's seat" but lets make sure the "car" is safe, sound, and adequate for the journey, as there are many twists, turns, and hazards ahead.

He needs help with basic tasks, from combing his hair to drinking a glass of water. Born with cerebral palsy, 26-year-old Michael Cherta relies on others to dress him, feed him or take him to places where he can soak up the sunshine. While his parents are at work during the day, licensed caregiver Pam Davison watches over Cherta and sees that his needs are met. She'll fix lunch and pick up medication. Davison will take Cherta, who is wheelchair-bound, to physical or speech therapy sessions. Sometimes, she stands up for her client when she feels he's being ignored or taken advantage of.

Cherta and Davison now are worried this three-year arrangement is coming to an end because Gov. Rick Scott and lawmakers are cutting back on services for the developmentally disabled. The state Agency for Persons with Disabilities needs to slash about \$90 million in services this year to meet its budget. The cuts not only affect contract workers like Davison, but employees in group homes who coordinate training programs, community outings and other activities for the disabled.

About 33,000 people in Florida with developmental disabilities like Cherta go through the agency to find companions who will not only care for them but also find ways to make them a part of their communities. The agency serves about 50,000 people with autism, cerebral palsy, spina bifida and intellectual disabilities. Prospective clients use a waiver program the agency offers through Medicaid that will keep them out of nursing homes, pair them with caregivers or get them accepted into group homes. Local nonprofits that run group homes and provide supported living programs say they are feeling the pinch.

"They've cut beyond the bone," said Richard Lilliston of Hillsborough Achievement and Resource Centers. "They've cut into our hearts, basically." Lilliston, the chief executive officer for the nonprofit that oversees nine group homes and 350 clients, has ordered a 4 percent pay cut for all employees. The Tallahassee-based state agency is no longer paying to transport clients to day programs and activities, he said. Ross O'Banion, executive director of Angels Unaware Inc. in Tampa, said funding issues have been going on for years, but this year's budget cuts have been especially brutal. "This is the worst I can remember over the last four years," said O'Banion, whose nonprofit serves 50 clients in eight group homes. "This is the worst it's ever been." Angels Unaware has laid off at least one employee in each of its group homes and cut all workers' pay by 8 percent, O'Banion said. The reductions trickle down to clients, whose "quality of life is not what it used to be." "These are folks with severe developmental disabilities," he said. "They can't live on their own. If they're in a group home, they're in a group home for a reason."

O'Banion and other care providers said that if state services go away, their clients may end up in nursing homes. Family members who rely on in-home companion services may resort to quitting work to care for a disabled relative or pay for medical nurses to do the job, Lilliston said. Melanie Etters, communication director for the disabilities agency, said she and other state officials have been working with families and care providers to lessen the blow of the cuts. "We're certainly trying to listen to people," Etters said. "Whenever you're going to change things it will be challenging. We do understand this affects people's lives."

One of the first cuts the agency implemented on Aug. I is adjusting the rate it pays caregivers to \$6.72 per hour, a 4 percent reduction in pay from the previous year. The minimum wage in Florida is \$7.31 per hour. Because of the pay reduction, Davison said she is considering taking on more clients to make ends meet. She has done it before, caring for Cherta in his Tarpon Springs home one day then driving to Clearwater to care for another person the next. She no longer provides care for the woman in Clearwater. Cherta is now her only client. While "it's easy to say you can work for three people at the same time," the reality is having multiple clients limits the quality of care she can give and the time she needs to do her job, Davison said. Cherta said he's worried the pay cuts may force long-time caregivers like Davison to find other jobs, leaving less experienced and less professional workers to fill the vacuum. He uses a device called a Dynavox to communicate. A screen, similar to a small computer monitor, connects to his electric wheelchair. A sensor on Cherta's eyeglasses allows him to "type" words on the monitor, which are then turned into audio clips. The device lets him surf the Web and write emails. "To me, it is a really a safety factor first and foremost," Cherta said of the pay cuts. "By cutting the rates, many of the experienced companions will be unable to provide services. Inexperienced workers can pose a risk."

The Agency for Persons with Disabilities has been in the red for much of its seven-year history. "The agency has historically spent more on services than we've been appropriated," Etters, the spokeswoman, said. "We're trying to bring that down." Contributing to the problem was third-party vendors offering services that clients ultimately didn't use, she said. This year, those services totaled \$1 billion. Scott gave the agency a \$174 million bailout in April to keep services going and lawmakers approved an \$810 million in state and federal funds for the current fiscal year. But the agency still has to cut about \$90 million in services to meet its budget. Vendors and clients now are being asked to go over the services they no longer use and report them to the agency, Etters said. "We're trying to reduce services in cost plans they don't need and talking to families who would voluntarily reduce unused services," she said. The agency must submit a plan by Sept. I to lawmakers detailing how it will further bring down its expenses and balance its budget. Caregivers said they don't know what the future holds. "I don't know what's going to happen," Lilliston said. "It's going to get worse before it gets better." Davison said she feels her career is in jeopardy. "What am I going to do? That's really hard for me to say right now," she said. "I work for bare, but I can't imagine doing anything else."
