#### A Word From Ross

#### Ross O'Banion, Executive Director

Most of you are aware that the budget session started 2 months early this year on 1/10/2012 with the goal to address two very important issues......reapportionment and the state budget (which is due by 7/1/2012). Some are suggesting that the budget discussions should be delayed until the March revenue estimates are revealed as Florida is facing a \$2 billion shortfall in general revenue. Naturally the House and Senate have different approaches and neither supports the other, but because of the current projections, the budget for individuals with developmental disabilities is, of course, at risk yet again with a projected \$40 million deficit for this fiscal year (2011 - 2012). So far, this fiscal year (2011 - 2012) has seen \$27.5 million statewide cuts with the average cost plan falling from \$37,000 to \$33,000, since the beginning of the fiscal year. Let see that would be about an 11-12% cut to Florida's most vulnerable population, yet again.

At the same time Senator Joe Negron has proposed SB 1516 that would narrow the scope of responsibility for APD in three areas......health, safety and prevention of institutionalization. Achieving independence will be reduced as a priority and will no longer be a directive for APD. At the present time there is no House companion bill but there could be a committee bill introduced in the House. In short, we would have programs in the community that provide 'three hots and a cot' so the DD individuals would not need to go to institutions but providers would need to seek donations from the community to provided anything else in the way of quality of life, training, meaningful day activities, community inclusion, integration, independence, etc....as Medicaid waiver has now become the 'payee of last resort'. I would bet that most of our day programs will not survive. Brilliant move Senator Negron! You have just moved the DD service delivery system back in time to the 1950-60s.

At this point anyone with any conscience would have to agree that neither of these ghastly proposals can be allowed to pass. The DD Council, ARC, FARF and others are asking the Legislature (House and Senate) for a minimum of \$865 million to the APD budget for current waiver recipients. The question today is "What will you do to prevent these two proposals from gaining traction in this legislative session?" Will you call your delegation, visit their offices, write their offices and write the editors of your newspaper and ask them to stop sending our citizens with DD back in time? Will you do it every week? Will you do it every day if necessary? As often quoted "evil triumphs when good men and women do nothing" What will you do?

Contact your local State Senators (<u>click here</u>) and your local State Representatives (<u>click here</u>) and the Governor's office (<u>click here</u>) and tell them (in your own words) what it would mean if you had to give up any of these services. Ask them to find their cuts above the service and provider's level. We can't handle more cuts in funding! <u>Click here</u> to ask (in your own words) the Senators on the Health Regulation Committee to vote against SB 1516.
