First off, I know this has been a very rocky start for the month of April. I want to thank everyone for their support in contacting the media, participating in rallies and contacting Tallahassee about the need to continue Medicaid Waiver Services without cutting the current rates. A big thank you goes out to the providers who, despite not knowing what the future holds, continue to provide services to ensure that the people we care about are safe and healthy!

There have been changes in the ABC (Allocated, Budget & Control) system daily. Support Coordinators are unable to send out service authorizations to providers and everyone has been requested not to bill so that the ABC system can be corrected. I know this is difficult for many of us who survive paycheck to paycheck. Please hang in there! In looking in ABC Unit rates are back to the 1:1 ratio for all services based on the new rate chart. Earlier this week they were at a 1:3 ratio. This is good news despite the fact that the unit rate still has been cut 15-40% for some providers depending if you were a solo provider or an agency.

The HCBS waiver provides services to over 35,000 individuals with over 19,000 on the waiting list. I do not know what the solution is but we all will need to step up a bit more, make our voices heard and speak up for those who are unable to speak up for themselves.
- "Since Monday, over 3,500 Floridians each wrote 162 emails to lawmakers to advocate for funding of our developmentally disabled. THAT'S OVER 567,000 EMAILS!!! Your voices were heard! The Senate will fund the deficit. Now the Governor must (should) rescind the cuts.
