Free In-Home Respite Care

For Children with Developmental Disabilities

It was brought to our attention by Rebecca High at Hillsborough County Department of Children's Services about an In-Home Respite Program for children with Developmental Disabilities. Qualifying families could receive up to 16 hours of respite care per month. Sounds good??? Let us give you more!

- 1. Services are provided at no cost to eligible children and their families.
- 2. Parent/Caregivers must be residents of Hillsborough County.
- 3. Children who receive services are infants through age 18.
- **4.** Eligible children must be identified by a licensed Physician or Psychologist as having one or more of the following significant developmental disabilities:

-Autism -

-Spina Bifida

-Intellectual Retardation/Deficiency

-Cerebral Palsy

-Severe Developmental Delay

-Prader-Willi Syndrome

A Word From Ross

A Word From Ross

Ross O'Banion - Executive Director

This year the Legislature and the state Leadership has taken the challenge of Medicaid reform, Growth Management, Terry Schiavo, Education Reform and much more. Personally, I would not like to be a Legislator in Florida this year. We all owe them a debt of thanks for their efforts regardless of their political views.

In the past few weeks there have been several articles across the state and the local area papers detailing the problems of the Developmentally Disabled in Florida. In regard to the Developmentally Disabled in those articles, there were a few items that were absolutely true.

- I. **ADP's hirelings are cutting services.** A company called Maximus is cutting these services. People with Developmental Disabilities have died while waiting for approval or after the services have been cut.
- 2. Has an Angels Unaware consumer suffered cuts? Yes some have, others certainly will, and some are currently in Chapter 120 Fair Hearings to try and stop their cuts. Will it result in death for some of these consumers, I certainly pray not, but if they did not need the services at a certain level we would not have asked for it. After all, who knows the consumers best Angels Unaware, Inc. and their families that have served them for extended periods of time or Maximus that does a desk review never meeting the consumer face to face?
- 3. There is a growing waiting list. Florida has remained in the lower rankings on the amount of money spent on the Developmentally Disabled per consumer care, in spite of the millions the Governor has added to the pie. The result is at this rate of growth everyone gets a smaller and smaller piece of the pie year after year.

For me the overriding question is "Is the quality of care and the quality of life for the developmentally disabled better today than a year ago?" The answer to that question is "NO"! As providers, we spend more and more time doing more and more paper work in an attempt to justify and document the services that we provide to the consumers we serve. These rates are ever decreasing due to inflation and increasing expenses. We spend more and more time meeting standards that are constantly being changed by new "interpretations" or "policy directives" that circumvent the rule making process and practical common sense. We are constantly battling staffing issues because we have rates that are not adjusted for actual expenses (inflation or rising costs just to name two reasons), and as a result our staff is getting paid less and less and is required to do more and more. Our staff is n being asked to make decisions and observations beyond their skill, training, and legal authority.

If you are planning to move to Florida and you have services elsewhere for your disabled child, sibling, or other family member, STAY WERE YOU ARE!!!! Help Florida practice Growth Management.


Letter From the President—Bob Albano
