### A Word From Ross

#### A Word From Ross

Ross O'Banion - Executive Director

Some of you may have read the article in the Tampa Tribune on 2/23/07 entitled "Florida's Neediest Brace for Change" - Ackerman. Apparently there is talk in Tallahassee of moving the Agency for People with Disabilities (A.P.D.) back under the authority of the problem racked Department of Children and Families (D.C.F.). I know that this action would be a mistake and I took the time to write to each of our State Legislators and Senators to let them know. Dennis Howe once said "Life is a comparison of where we are with where we would rather be. Are we standing, moving or arriving?" Granted, A.P.D. has not yet "arrived" to the point that we and our consumers need the Agency to be but the real question is "Where are we? Are we standing, moving, or arriving?" In the years since A.P.D. and D.C.F. were separated, we have done some "standing" and some "moving". I believe that we should ask "What do we need to do to meet the needs of the consumers we serve within the State of Florida?" Simply stated, the following are my suggestions:

- We need a unified philosophy of treatment. Currently we have at least two models. The "Medical" model is the one that state and federal government use for funding. The other one is the "Community Inclusion Base" model that the consumers and their families want. Our consumers are disabled, not sick.
- Once the treatment philosophy conflict is settled, we competent leadership to "steer" the course. We currently have several individuals within our state that have that knowledge.
- We need a rate structure that is based on fact. We need a rate structure that is fair and is kept current with recognized economic factors in our state. It should be structured to place the providers of service in a sound economic position to allow them to expand and meet the ever growing waiting list problem.
- We need a fair method of accessing the needs of the consumers that is based on nationally accepted instruments such as the AAMR - Support Intensity Scale. The current utilization review method involves the agency making haphazard decisions on services for consumers that they do not know and have never met. That is a recipe for disaster. It wastes the resources of the consumers and the providers, especially with the constant appeal process that is involved with the current

Do we need to go back under D.C.F.? I do not think so. I believe we need to fix A.P.D. were it is, moving problems around never solves them. Now is the time to let your representatives know. Please call them, write them, sit down with them, and let them know what you need, want, and desire. I am sure that you join me in the desire to move from just "Standing" to "Arriving".

Our goal is to have one organization that we can count on to get the work completed and reduce or eliminate the costs associated with maintaining a house.

The "Adopt a Home" program addresses the personal side of our homes. Adopting a home puts an organization in direct contact with the residents. Our goal is to develop a long-term, personal relation-

Birthday parties, holiday gifts and decorations, escorts for special events, picnics, theme parks, church and community services are a few areas that we need your help.
