
Angels Make The Holidays Special

Speaking Out Column

Earning Respect ... We All Still Have So Far To Go

We have come so far, but have so far to go. By we, I am referring to the population that Angels Unaware serves and the people who know them. Not just the people who work with them, but their friends, family and all the people in the community who interact with them.

I watch with satisfaction as some of my residents shop for groceries. I marvel not just at the residents but at the check-out person who doesn't alter her behavior when they go through her line. I marvel and think that we have come a long way.

Then along comes an experience that sets me back. Angels III recently went on a vacation. The vacation didn't go along as planned; however, most of the mishaps I can look back on and have a good laugh. Unfortunately, one series of events, I cannot.

We had booked our rooms about a month in advance. When making the reservations I follow a script which closes with, "... we will be arriving on [...] and will be paying by company check in the amount of [...]." All went well, until I took a some residents with me to prepay our stay.

When we arrived, we were told that the hotel could not accept the check. The hotel personnel were courteous but intractable. We had stayed previously withother hotels within the chain and had no trouble. I called the chain's office and was told to pay at a local hotel (in Tampa) and get a voucher. This was done, and the voucher was in my hand, but before I had gone back to my office, the hotel had

called and informed us that they would not be able to honor the voucher if it was paid by check.

To resolve the problem, the check was made out to me, and I would, in turn, pay the local hotel for the rooms on a personal credit card and then take the voucher to the Orlando hotel. This worked with the local hotel, but the Orlando hotel told the local hotel they still would not honor the voucher.

The conclusion I was left with was that we were not welcome. It was too late to get rooms for 14 at another hotel in Orlando. And disappointing the residents was not an option. They certainly had done nothing inappropriate. We paid the Orlando hotel cash for the rooms.

Once we arrived, it became more apparent that we were not welcome. No one was rude or overtly unkind. We were simply avoided and ignored. The best example of this was in the mornings. I am an early riser. At 6 a.m. the first morning, I went down for breakfast alone and received excellent service. The next morning, I took two residents with me, and we were ignored – no Good morning; no The coffee is over there; nothing.

Experience tells me that the best response is exposure. Expose them to us, and let them get to know the reality of our residents. It works. I've seen it work. It worked with the check-out lady at the grocery store, and it can work with hotel managers. We need to be out there. We need to show them who we are.

Respect must be earned. We have to earn it, and people like those in that hotel will have to earn it as well.

Angels Unaware Continues To Grow

ngels Unaware is blessed as we continue to grow and make a difference in the lives of our developmentally disabled residents.

A New Group Home Is Added

As we went to press, plans were under way to close on the purchase of a house that will become Angels VI, a group home for non-ambulatory residents. After closing, extensive renovations will need to be made to better serve our nonambulatory residents and their wheelchairs, walkers, lifts and other special equipment.

When the home is ready, some Angels II residents will move over to Angels VI, alleviating the crowded conditions at Angels II. Plus two young women (Angela and Andrea) are patiently waiting to join the Angels Unaware family as new Angels VI residents.

The home is near Angels II, making it easier for Elizabeth Alexander, Facility Director at Angels II, to also become the Facility Director for Angels VI.

Two New Vans Are Delivered

Angels Unaware now has two brand-new vans - thanks to two DOT grants and the funds raised from last year's angel ornament sales. Both vans have been modified to meet the special needs of our residents.

The non-wheelchair van was completed and delivered in October. However, the wheelchair-accessible van required more extensive modifications and was not ready for delivery until late November.

With both vans now in action, group outings are much easier and certainly a lot more fun for our residents and for their caregivers.

Residents' Scholarship **Fund Needs Donations**

A ngels Unaware's scholarship fund helps our residents when their personal savings accounts are low, so they won't miss out on activities or go without needed medical care or personal items.

Since the State of Florida does not cover many of their health care needs and medications, residents often pick up the full tab. Frequently, prescriptions alone can deplete their account — money they have saved from SSI and "far below minimum wage" earnings from their employment at sheltered workshops.
